



Data for Policy 2024 – Conference Assistants

Role Summary

We require volunteers to assist with the running of Data for Policy Eighth International Conference, to be held at Imperial College London, July 9 – 11, 2024. This is a fantastic opportunity for anyone interested in the nexus of policy and data to attend the premier global conference in this space. It is also a valuable opportunity to gain experience in large event management, and associated communications.

Role responsibilities are likely to include a mix of the following:

Working as part of a team of volunteers to deliver the conference:

- Ensuring good communication with team at all times
- Responding flexibly to short notice demands arising during the conference

Set-up:

- Becoming familiar with conference venue
- Working with local hosts to ensure rooms are set up, signage in place, etc.

Session management:

- Assisting delegates with room locations
- Work with Chair to deliver session to time
- Prompt communication of any issues to appropriate person
- Handle roving microphones for audience questions

Assisting with hybrid delivery of sessions:

- Hosting or co-hosting sessions
- Managing remote participation
- Working with the session Chair to manage questions

Managing delegate conference experience:

- Running welcome desk and check-in
- Responding to general delegate enquiries

Communications

- Assisting Communications team preparing content for social media posts before, during and after the conference

Success Measures:

- Conference runs to time
- Networking / break-out sessions well-run in all respects
- Conference delegates satisfied with conference experience
- Communications leading to engagement from the wider community



Behaviours and Attitudes:

- Able to act on own initiative
- Excellent timekeeping
- Confident, professional manner
- Flexibility and ability to adapt to changing situation
- Ability to solve problems as they arise
- Able to work independently or as part of a team

Skills Knowledge, Experience and Qualifications:

- IT literacy and experience of online meeting software
- Educated to degree level in a subject relevant to the role and/or the conference
- Interest in data science and policy-making
- Experience of conference participation, in any capacity
- Experience of volunteering, in any capacity
- Experience of customer-facing role
- Experience of preparing social media material
- Experience of content creation/blogging/reporting

We expect candidates to have at relevant experience/knowledge/qualification in at least five – six of these.

Training:

Training will be provided online before the conference. Training will also require in-person attendance at Imperial College before the conference.

Time commitment:

Before the conference, remote training, familiarisation and preparation, up to 20 hours. For the conference period 8 – 11 July, full-time equivalent work is required, but some flexibility may be possible.

Expenses:

Local travel expenses, with proof of costs incurred, will be reimbursed after the conference. Lunch will be provided at the conference.

Each year we host around a hundred speakers after a thorough peer-review process hosting key global stakeholder views from across prestigious academic institutions, government departments, international agencies, non-profit institutions, and businesses. In 2024, the theme of the conference is the hot topic of the moment – governance *with* AI.

The conference will run over three days in-person with hybrid elements, with a mix of plenary panels, keynote talks and short presentation sessions, featuring speakers from more than 30 countries. There will also be networking opportunities across the three days.
